- Whereas after technical evaluation 7 (Seven) bidders qualified for the financial evaluation.


- Whereas the **Clause No. 24 of the Terms and Conditions** of the tender document clearly stipulates that *"No bidder shall offer unreasonably low rates with an intent to secure the contract unfairly, failing which the tender shall be rejected without any further correspondence."*
- Upon the detailed examination of the financial Bid, it was found that most of the bidders have quoted **unreasonably low and commercially non-viable**, indicating an attempt to undercut competition and secure the tender through unfair means.

6. Whereas these quoted rates are significantly below the prevailing the market prices and raise serious concern regarding quality, hygiene and sustainability of the services provided under contract.

Therefore in view of the above mentioned reasons and ensure that the essential canteen services are not compromised in terms of quality and public health standard and hygiene. It has been decided to cancel the tender bearing No. SPC/865, Tender ID: 2025\_HED\_278992\_1 in terms of Rule 173 (XIX) of GFR 2017.
