Consequent upon the conduct of the NEET (UG) examination on 21-06-2026 and the public holiday for Kashmir Division colleges on 22-06-2026, the following schedule updates are hereby notified for all candidates seeking admission to Undergraduate (UG) and Integrated P.G. Programmes in Government Degree Colleges of J&K:

- **Physical Document Verification:** The last date has been extended to **23-06-2026 (till 4:00 PM)** instead of 22-06-2026.
- **Online Fee Deposition:** The deadline for the deposition of fee for Round-2 College/Major Allotment List remains unchanged at **22-06-2026 (by 2:00 PM)**.
