# **Submission of Bids**

Bidders must submit their bids online through the e-Tendering Portal <u>www.jktenders.gov.in</u> only. Bidders are required to submit both the **Technical Bid** and **Financial Bid** separately.

# A. Technical Bid

The **Technical Bid** should include the following documents:

1.	Certificate of Dealership from the OEM/OEM Authorization certificate.	
2.	Experience certificate (Minimum Three Years) of supplying the Spectrofluoromet which the supplier intends to quote. Supply orders/CRACs/satisfactory performance certificates (from the competent authority) of the quoted equipment for at least three years need to be uploaded to substantiate the claim of having requisite experience.	

3.	Original copy of the company catalogue/Data sheet of the model quoted in support of the above-mentioned specifications. The catalogue must clearly specify the brand, model no and specifications of the equipment.
4.	GST registration Certificate
5.	Copy of the PAN of the firm/Proprietor.
6.	The tendering firm shall furnish an undertaking to the effect that the tenderer has never been blacklisted.
7.	Turnover of the firm for last three years.
8.	Bidder Information Form (Firm name, Contact No., e-mail, etc)

#### **FinancialBid**

A standard BOQ format has been provided with the tender document to be filled by all the bidders. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. Bidders are required to download the BOQ file, open it and complete the unprotected cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid is liable to get rejected.

The quoted price (including taxes) shall include the cost of the item and all other accessories as listed in technical specifications.

#### **Evaluation Criteria**

#### A. Technical Evaluation:

Bids will be evaluated based on compliance with the eligibility criteria, past experience, and other technical aspects as specified in the tender document (documents 1-8). Bidders who fail to qualify in the technical evaluation will not be considered for financial evaluation.

## **B. Financial Evaluation:**

The technically qualified bidders offering lowest price will be considered the **lowest bidder** (L1) and deemed qualified for the bid. In the case of identical lowest prices, all the tied bidders shall submit a further reduced price in a sealed envelope, and the bidder offering the lowest price among the tied L1 bidders will be awarded the contract; if the tie persists, factors like higher turnover or relevant experience will be considered to select the final winner.

#### **TERMS & CONDITIONS**

- 1. The tenders shall only be entertained through online mode on website <u>www.jktenders.gov.in</u>
- 2. The tenderers are required to submit both the **Technical Bid** and **Financial Bid** separately.
- 3. The tenderer must have minimum experience of three years of supplying the Spectrofluorometer which he intends to supply. Supply orders/ CRACs/satisfactory performance certificates (from the competent authority) of the quoted equipment for at least three years must be uploaded to substantiate the claim of having requisite experience.
- 4. The Tenderer should clearly mention make and model, also enclose Catalogue/Data sheet of the Model quoted in support of the above-mentioned specifications.
- 5. The tenderers are required to upload soft copies of all other documents specified in the tender document.
- 6. The tenderers are advised to check the applicable GST rates on their own before quoting. Buyer will not take any responsibility in this regard.
- 7. The successful tenderer must supply the item and all other accessories as listed in technical specifications
- 8. Actual delivery of the items is to be made at Sri Pratap College, M.A. Road, Srinagar, Jammu and Kashmir, 190001.
- 9. If the item/s are found to have incorrect specifications or specifications not mentioned in the tender document, the supplier is responsible for removing the items from the college at their own expense. The college shall not be responsible for any loss or damage to the items between their delivery and their removal from the college.
- 10. The college shall not be responsible for any loss or damage to the items during their transportation.
- 11. It shall be the responsibility of the tenderer to undertake the installation of the item at Sri Pratap College, M.A. Road, Srinagar, as and when instructed by the purchaser. The quoted price must include the installation charges.
